#### **Terms & Conditions**

#### 1. Securing The Date

Your wedding date can be secured before your hair/makeup trial with a £50 non-refundable deposit, which will be deducted from the final invoice.

Arranging a trial does not reserve my services for your wedding day.

### 2. Payment

Payments can be made in cash or via bank transfer, cheques will not be accepted. The trial is paid for at the time of trial by cash.

The fee (50% of the final bill) is to be paid 7 days after your trial. The remaining amount is to be paid in full one month (28 days) before your wedding. Failure to pay the fee within the stated time can result in your wedding date being cancelled by me.

#### 3. Responsibility of the Client

You, the client shall inform me, the makeup artist/hair stylist of any issues that may affect the use of any equipment or products. This includes but is not limited to sensitivities, allergies and medical conditions. I cannot be held liable for any losses or damage that is incurred due to your failure to inform me of any known condition. I reserve the right to refuse service to you or members of your wedding party for, but not limited to, anything contagious (for example cold sores and headlice).

#### 4. Cancellations

At any point you can cancel the wedding date by informing me in writing. I will be under no obligation to refund any money paid up until point of cancellation, however you will not be liable for any further payments.

You can cancel a trial at any point, however a trial cancelled with less than 24 hours' notice will be charged for at the agreed rate.

Cancellations by me due to circumstances including, but not limited to, problems rendering the performance of my obligations and where no other suitable alternative can be given will result in a refund to you. No further compensation will be offered.

If the booking is directly affected by circumstances beyond my control every possible endeavour to rectify such situations will be made, however no compensation will be offered on my part. You are strongly advised to take out wedding insurance to cover against such situations.

#### 5. Exclusivity

Exclusivity is not guaranteed for the whole day of your wedding date; therefore, timings will be seriously considered when agreeing to any booking. It is unlikely that there will be another event on the day; and any second event undertaken by me will not affect the first event.

An exclusivity fee can be arranged if preferred.

#### 7. Travel Expenses

Travel is charged after the first 25 miles at 45p per mile for both your trial and wedding day. My post code is TN9 1UD.

All car parking expenses, toll and congestion charges incurred for both consultation and wedding days will be recharged to you at cost.

#### 8. Assistant Fee

If your wedding party is for full hair and makeup for more than four people, I will be accompanied by an experienced assistant for which there will be an additional fee of £100.00. This will be added to your invoice.
